Contact center professionals view real-time performance data and instant messages directly on their workstations. Whether agents work on-site or remotely, they can view real-time reporting for any metrics their centers utilize, including average answer and talk time, call in queue, and calls abandoned. These numbers show on the CMS panel and dashboard on an agent's desktop and can include information such as individual performance measurements and objectives, and personalized motivational messages. This kind of quick feedback gives agents powerful tools to improve the performance and productivity of the center.
