Avaya Workspaces for Elite as a web-based multi-channel agent desktop Contact Center application. It provides Avaya Call Center Elite agents to improve productivity and the overall customer experience by integrating multiple applications into a modern, consumer-like, agent desktop.

The statements in this document cover the additional agent functions provided by outbound widgets to perform integration of Workspaces for Elite desktop with the Proactive Outreach Manager agent based dialer.
